

SUMITOMO CHEMICAL AUSTRALIA: BANANA MONEY BACK PROGRAM

FULL CONDITIONS OF OFFER

1. Information on how to register and claim for the money back guarantee offer (**Offer**) forms part of these Conditions of Entry. By registering for or claiming this Offer, you accept these conditions of Offer.
2. Offer is open to Australia's banana growers that receive the official mailer invitation from the Promoter.
3. The Promoter reserves the right to verify the validity of registration or claims (including a registrant's identity and address) and reserves the right to reject any registration or claim if, in the Promoter's reasonable belief the registration or claim is false, invalid, tampered with or ineligible or which is not in accordance with these conditions of Offer.
4. **Offer Registration.** To be eligible for the Offer, eligible persons must: (a) purchase 5L or more of Shield Systemic Insecticide product(s) in the one transaction from an authorised reseller between 1 June 2009 and 31 December 2010 (**Offer Period**); (b) register for the Offer by completing the official registration form which can also be downloaded at the Promoter's website at *www.sumitomo-chem.com.au*; and (c) fax or mail the completed form (including all relevant details) to the Promoter, as directed together with a copy of the purchase invoice/proof of purchase, within the Offer Period, for the eligible product purchased. Completed registrations must be received by the Promoter within 60 days of purchase of the eligible product.
5. Maximum of one Shield Systemic Insecticide claims per eligible claimant.
6. **Claims Process.** To qualify for receiving the Offer, eligible claimants must: (a) trial the eligible product for a minimum of one season from the purchase date within the Offer Period; (b) use the eligible product according to the exact label directions (product information and detailed label instructions can also be found on the website set out above); and (c) specify honestly why they were dissatisfied with the product. Submitted claims must relate to the use of the product purchased, and the season in which it was used. Claimants must submit a claim to *The Marketing Manager, Shield Banana Promotion, PO Box 60, Epping, NSW 1710*.
7. The Promoter retains the right to evaluate the technical aspects of product usage prior to issuing a refund to any potential claimant. Only the cost of the product (as identified on the proof of purchase will be refunded). All valid claims will receive a cheque valued at the purchase price as per receipt enclosed in the registration form. Cheques will be issued to the person named on the registration form within 30 days of the claim being investigated and accepted by the Promoter. Only those claimants who provide all the required information will be eligible to receive the Offer.
8. Promoter's evaluation decision is final and no correspondence will be entered into. No responsibility accepted for lost, late, or misdirected registrations or claims.
9. If this Offer is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any claimant; or (b) to modify, suspend, terminate or cancel the Offer, as appropriate.
10. Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity or loss of profits); whether direct, indirect, special or consequential, arising in any way out of the Offer, including arising out of any registration or claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter.
11. All registrations in this Offer become the property of the Promoter. By submitting a registration form, unless otherwise advised by you, you consent to the information submitted being entered into a database and the Promoter may use this information to contact you with exclusive offers and updates for products from the Promoter without any reference or payment or other compensation to you.

12. The Promoter will collect your personal information to enable it to conduct the Offer. In administering the Offer, the Promoter may disclose registrant's personal information to organisations to which the Promoter outsources functions, such as mailing houses and organisations associated with the Offer. All personal details of registrants will be stored at the office of the Promoter. A request to access, update or correct any information should be directed to that office.
