## **Products to be used:**

VECTOBAC G BIOLOGICAL LARVICIDE GRANULE [APVMA No. 52834]

Containing: *Bacillus thuringiensis* subsp *israelensis* Strain AM65-52 fermentation solids and solubles, as the only active constituent

#### **Directions for Use:**

Situation	Target Insect Pest	Application Rate
Stagnant seasonally inundated basins and standing ponds of fresh and brackish water Storm water retention areas	Freshwater Mosquito Larvae	7 kg product / ha

#### **Critical Use Comments**

- Apply products as per recommended label use.
- Apply when third instar or younger larvae predominate. Fourth instar larvae and pupae will not be controlled by *VectoBac G*.
- Repeat application as required, with minimum 7 days between consecutive treatments.
- Apply by ground application only using calibrated granule spreader.
- Adhere to all Restraints and precautions as per the current product label.

## **Jurisdiction:**

QLD only; specifically fresh or brackish ponding or flood water mosquito habitats within the City of Gold Coast boundary.

# **Additional Conditions:**
