CONDITIONS OF USE

Products to be used:

PYGANIC ORGANIC INSECTICIDE (APVMA No. 59684)

Containing: 13 g/L PYRETHRINS as the only active constituent.

Directions for Use:

Situation	Pest	Rate
Food processing establishments, factories, storerooms, warehouses and external areas associated with such establishments that are used for processing and handling organic produce	Indian Meal Moth (<i>Plodia interpunctella</i>)	Surface Spray: 30-90 mL/L Lower rate is for adult moths and the higher rate for larval stages
		Space spray: 30 mL/1000 m ³

Critical Use Comments:

- DO NOT allow contact with food or food utensils.
- Apply prior to the preparation or storage of the food items.

Before use:

- Remove or cover all exposed foodstuffs, dishes, utensils and surfaces where food is prepared.
- Before spraying, remove animals and pets from the areas to be treated.
- Cover or remove any open food and water storage containers.
- Cover or remove fishponds, aquariums, etc. before spraying.
- Area must be cleaned of waste grain/food, cobwebs and other debris from walls, floors, ceilings and rafters.

Application:

- Apply as a surface spray using knapsack or space spray using cold fogging or misting equipment.
- Dilute with suitable volume of water and direct spray or fog to all parts of the area.
- Spray all surfaces with special attention to areas where pest is present and congregates e.g. mouldings, drains, sinks, grain divider boards, bins cracks, crevices around the base of machinery and equipment.
- Keep windows and doors closed when spraying or fogging.
- *Synertrol Horti Botanical Oil Concentrate* can be used at a rate of 200 mL/100 L.
- DO NOT store diluted insecticide. Prepare a fresh solution as necessary.
- DO NOT spray the moving parts of any machinery, electric motors or switchgear.

After use:

- Thoroughly ventilate treated area and thoroughly clean all surfaces that may come into direct contact with food before resuming processing, handling or serving.
- DO NOT re-enter treated area until spray has dried.

All States and Territories.

Additional Conditions:

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.
